Details of submission arrangements in each state/territory are available in the *NMA Standard Principles for Operation* and *NMA Fact Sheet*.
- Allocation of a multi-centre application to a reviewing HREC in Queensland must be via the Central Coordinating Service ([CCS](#)).
- Allocation of a multi-centre application to a reviewing HREC in Victoria must be via the Central Allocation System ([CAS](#)).

### Information for Section B

- For each site in a NMA research project, a research governance application must be submitted electronically, with supporting documents, to the site's Research Governance Office. Details of the research governance application form and submission arrangement in each state/territory are available in the *NMA Standard Principles for Operation* and *NMA Fact Sheet*.
